President's Report: Steve Hockman said there is nothing to report other than a great women's class put on by Tonya Sies.

Vice-President's Report: David Sies said things have been slow but we have added three new memberships.

Executive Officers' Reports:

Munger - David Alexander said the porta-johns have been cleaned and the range truck has been moved. Steve Hockman reminded Dave that the trash has to be dumped. Dave said that we can throw trash on Duane Ackerman's burn pile.

Linwood - Ken Mac Connell said nobody cleaned up after the Democrat shoot. The indoor thermostat is done. He wondered who is getting the mail. The pop machine is not working. He will clean out the furnace blower. We still need a timer on the large range fan.

Unfinished Business:

New Business:

Steve Hockman believes we need to have the range committee write up the rules and send them to all members and that they should be visibly posted all over the range. Current Range Committee members are: Tonya Sies, Steve Hockman, David Sies, Shaun Crawford, Mike Korn, and the Discipline Directors.

- 2) **Shop With A Hero Benefit** - Scott Rifenbark would like to borrow two drop turns, fifteen stands, and some steel targets for the September 26 Law Enforcement fundraiser. **Motion to lend the materials made by Doug Young. Seconded and carried.**

- 3) **Other Miscellaneous** - Steve Hockman said he would like to see more regular members present at the monthly meetings. Doug Young said Frank's Great Outdoors would like to give us another banner. He also had a question on orientation times. Tonya Sies is thinking about doing a beginners class for men similar to the one for women. She would also like to apply for a women's grant from the NRA. **Motion to allow Tonya to apply for the grant made by Steve Hockman. Seconded and carried.**
